#### 2223/87 Chairman's remarks

Councillor Breen welcomed the members of the public and Nicola Mansfield-Smith as the new Town Clerk. He further said there would be an electrician coming to install an electric point which will join to the generator, when the timing was available although the payment to be sanctioned will be brought back to finance.

It was also mentioned that since the agenda, notification has been received that a single tree to be taken down at Parkview will now be going ahead.

#### 2223/90 Minutes of the Previous Meetings

**Resolved** that the minutes of the meeting of the Council on Monday 10th October 2022 be signed as a true and accurate record.

## 2223/92 Reports from Invited Guests and District / County Councillors

Councillor Breen asked if anything needed to be raised and a member of the public mentioned that there was no sign from National Trust, however Councillor Breen said that it could be taken under agenda item 2223/94.

#### **2223/93** Planning

a) **Resolved** to propose a response in favour of the application but outlining a number of reservations that were raised by members of the public. These included the colour of the mast, the source of the mains power supply and whether it required further planning consent including the upgrade to 5g.

#### 2223/94 Highway Matters

**Resolved** to receive an update on the following:

- a) National Trust have said they would clear paths but this has not been done yet, although the Council need to know when this will be done, as the main problem in the winter is getting across the path.
- b) Councillor Breen reported that there was no response on Area 5 and had difficulty getting a response from Craven District Council as this is clearly a problem with the channel under the road between the two walls between Oughtershaw Village and Oughtershaw Hall.
- c) Nothing was reported from the Road Safety Working Group.

a) A consultation has taken place to group with Settle. Feedback was given that it was an inappropriate group of communities. Not outcome has been received other than they have a sympathetic view and had similar feedback from other areas of the community.

a) An application to the Lottery funding should be received by Christmas which covers the cost of the generator and switch but in the interim period a quote has been received for £63.00 for an extension lead.

**Resolved** to approve the motion from Councillor Breen in order to approve the expenditure for this.

**Resolved** to receive the following update:

a) Councillor Vetch has received the approval to buy the missing documents and the risk analysis will be completed before the next meeting.
